Established in 1980, the goal of the Area 1 Agency on Aging is to help the senior citizens of Humboldt and Del Norte counties realize dignified and independent lives by ensuring that their social and nutritional needs are met. As one of the 33 Area Agencies on Aging in California, A1AA provides the planning, coordination and, in many cases, actual delivery of services and supports that meet the identified needs of our elders in this bi-county service area.

As with our sister organizations that provide a safety net for the most vulnerable in our society, A1AA has contended with the challenge of annual reductions to its financial support in recent years. # A1AA Program Highlights 2010-2011

## **SENIOR INFORMATION and ASSISTANCE (I & A)**

I & A is the single access point for seniors, their families, caregivers and professionals to obtain information and connections to critical services. A1AA Resource Specialists responded to 4,400 inquiries from seniors or family members and referred to appropriate services.

#### HEALTH INSURANCE COUNSELING AND ADVOCACY PROGRAM (HICAP)

HICAP provides individual client counseling, community education, and informal advocacy regarding Medicare and related programs. A1AA's certified HICAP counselors:

- Assisted 3,000 individuals with selection of Medicare Part D plans and resolution of other Medicare questions
- Saved Humboldt & Del Norte Medicare beneficiaries approximately \$2,197,500

#### **CAREGIVER SERVICES**

Caregiver Services provides training and support to seniors, caregivers and their families. Our caregiver registry provides referrals of trained caregivers to seniors and people with disabilities. A1AA's Caregiver Services staff:

- Conducted six caregiver training classes and graduated 117 caregivers
- Provided 750 hours of respite care to 50 clients

## **VOLUNTEER CENTER OF THE REDWOODS & RSVP (VCOR/RSVP)**

VCOR/RSVP ensures that volunteers get connected to meaningful opportunities to serve with positive impacts in their community. Volunteer program staff:

- Referred over 1,000 individuals to volunteer opportunities
- Supported 556 RSVP volunteers who gave more than 130,000 hours of service
- Launched the Volunteer Driver program to provide free rides for seniors to their medical appointments

#### **NUTRITION & WELLNESS**

- Distributed 250 Senior Farmers Market coupon booklets
- Launched a home-delivered meals program in rural Eastern Humboldt County
- Provided a Diabetes Screening Program and distributed 8,000 educational handouts

#### A1AA CONTRACTED SERVICES


A1AA acts as a pass-through agency to non-profits that provide senior meals, legal services, Adult Day Health Care and Ombudsman representation in local care homes. Among their numerous accomplishments, A1AA subcontractors:

- Served 57,600 meals at six lunch sites and delivered 69,500 meals to 530 homebound seniors
- Provided 2,500 hours of legal advice to seniors


# **A1AA Financial Operations**

The Area 1 Agency on Aging is a 501(c)(3) organization responsible for the stewardship of federal, state, county and city funds with 70% of our total funding provided by the California Department of Aging. In addition, grants and contributions are received from foundations, private donors and fundraising efforts and the Agency benefits from a 50% ownership interest in its 434 7<sup>th</sup> Street building. A1AA has enjoyed a history of unqualified audit reports by an independent CPA and favorable monitoring reports from its oversight agencies.
